# **Summary**

Lloyd's has streamlined its authorisations in Gibraltar, allowing the market to continue writing term-life and all classes of non-life Gibraltar business on a cross-border basis, and through Gibraltar based coverholders. Lloyd's underwriters will cease to have a General Representative in Gibraltar as of 1 June 2025 and therefore service of suit provisions should be amended accordingly.

# **Background**

Since 1 January 2016, Lloyd's underwriters have been authorised to write Gibraltar insurance business on a freedom of services basis (not including Class 10 motor third party liability) and a freedom of establishment basis. As a requirement of the freedom of establishment authorisation, Lloyd's underwriters appointed a General Representative in Gibraltar in 2016.

### **Authorisation changes**

Lloyd's has recently undertaken two key changes to its authorisation in Gibraltar.

#### Freedom of Services

Lloyd's underwriters have added Class 10 motor third party liability to its freedom of services authorisation. As a result, Lloyd's underwriters are now authorised to write term-life and all classes of non-life insurance business on a freedom of services basis.

#### Freedom of Establishment

Lloyd's underwriters will no longer be authorised to write Gibraltar business on a freedom of establishment basis from 1 June 2025.

#### Accessing Gibraltar Business from 1 June 2025

From 1 June 2025, Lloyd's underwriters may continue writing term-life and all classes of non-life Gibraltar business on a cross-border basis, and through locally established coverholders (see Gibraltar Crystal page 'Distribution Channels' section for all routes to access Gibraltar business.)

## Lloyd's General Representative

As a consequence of the withdrawal of Lloyd's underwriters' freedom of establishment authorisation, the appointment of the current Lloyd's General Representative in Gibraltar will end on 1 June 2025.

#### **Service of Suit**

For business written on a freedom of services basis, the service of suit nominee is at the discretion of the underwriter. However, for the benefit of the market, Lloyd's have empowered the Lloyd's Agent in Gibraltar to accept service of suit on behalf of Lloyd's underwriters from 1 June 2025. Policies nominating the Lloyd's General Representative should be appropriately amended to reflect the position beyond 1 June 2025, nominating either the Lloyd's Agent or a nominee of their choosing.
